The Kosovo Prosecutorial Council, based on Article 7 paragraph 1 under paragraph 1.11 of Law No. 06/L-056 for the Kosovo Prosecutorial Council, article 26 paragraph 1 under paragraph 1.3 of Law No. 08/L-167 on the State Prosecutor, articles 12, 14, 16 and article 23 paragraph 2 of Regulation No. 02/2021 for the Transfer and Advancement of State Prosecutors, and based on the Decision of the Kosovo Prosecutorial Council, KPC/No. 1015/2023 of December 22, 2023, announces:

INTERNAL ANNOUNCEMENT

To fill one (1) position for prosecutor in the Serious Crimes Department of the Basic Prosecutor's Office in Ferizaj

- I. State prosecutors must meet the criteria for advancement Serious Crimes Department of the Basic Prosecutor's Office in Ferizaj as follows:
- 1. To be a prosecutor with a permanent mandate;
- 2. Have sufficient or higher performance rating;
- 3. "Sufficient" rating according to Regulation No. 12/2015 for the Performance Evaluation of State Prosecutors is an obstacle to advancement, until the evaluation of the prosecutor according to Regulation No. 05/2020 for the Performance Evaluation of State Prosecutors;
- 4. To have no disciplinary measures in the last five (5) years, with the exception of non-public reprimands and remarks;
- 5. To have no criminal investigation initiated;
- 6. Have a high professional reputation;
- 7. In the case of advancement, participation in trainings in the specific field related to general knowledge in criminal procedure, legal remedies, legal practice of local and international courts, academic preparation, scientific papers, lecturing at the academy or university level, engagement of the prosecutor in the prosecutorial

system and participation in local or international projects as an expert and participation in investigative teams will be taken into account.

- II. In addition to the general criteria, candidates applying for advancement must also meet the special criteria as follows:
 - In order to exercise the function of prosecutor in the Special Prosecutor's Office
 of the Republic of Kosovo, the prosecutor must fulfill the conditions to work as
 a prosecutor in the Department for Serious Crimes, as well as have a positive
 performance evaluation.
- III. The candidate who applies for advancement must complete the form for Advancement and Transfer of State Prosecutors¹ and attach the following documents:
 - 1. Evaluation of the Chief Prosecutor of the relevant prosecution for the last three years;
 - Certificates of participation in trainings;
 - Documents or other relevant or objectively verifiable data, such as knowledge
 of a foreign language, teaching at university level, scientific publications,
 participation in local or international projects as an expert and participation in
 investigative teams.
- IV. The Kosovo Prosecutorial Council encourages female prosecutors and prosecutors from non-majority communities to apply.
- V. The deadline for submitting the request is from December 28, 2023 to January 11, 2024.
- VI. The request must be submitted to the Coordinator for Appointment, Transfer and Advancement of State Prosecutors, Mrs. Ismije Maxhuni, on the sixth (6) floor of the State Prosecutor's building, "Luan Haradinaj" street Prishtina, office number 602, sealed in an envelope, or by mail.
