Kosovo Prosecutorial Council, based on Article 7 of Law no. 06 / L-056 on the Kosovo Prosecutorial Council, Article 3, Article 4 paragraph 1 under paragraph 1.1, Article 5 paragraph 1, 4, 5, 6 of Regulation no. 06/2019 on the Appointment of the Chief State Prosecutor and Chief Prosecutors of the Prosecution Offices of the Republic of Kosovo, and based on the Decision of the Kosovo Prosecutorial Council, KPC / No. 130/2022 dated 12 January 2022, announces:

COMPETITION

For the Appointment of the Chief State Prosecutor

- I. Candidates interested in the position of Chief State Prosecutor must meet the following criteria:
 - 1. To be a prosecutor with a permanent mandate;
 - 2. Not to have indictments filed;
 - Not to have been convicted of a criminal offense;
 - 4. Have a positive performance rating in the last three years;
 - 5. Not to have disciplinary sanction imposed in the last five years, excluding reprimand and non-public reprimand;
 - 6. Have a high professional reputation and moral integrity;
 - 7. Must have at least eight (8) years of work experience as a prosecutor.
- II. Candidates interested for the Chief State Prosecutor must submit:
 - 1. Application form;
 - 2. Self-assessment form;
 - Concept paper form for Chief State Prosecutor for the management of the State Prosecution;
 - 4. Curriculum vitae (CV);
 - 5. Certificate from the court;
 - 6. Any other relevant documents to document their experience, including recommendations.

- III. The Kosovo Prosecutorial Council encourages female candidates and candidates from non-majority communities, who meet the above criteria, to apply for the position of Chief State Prosecutor.
- IV. The deadline for submitting the application is from January 17, 2022 to February 4, 2022.
- V. The application together with the accompanying documents must be submitted to the Acting General Director of the Secretariat of the Kosovo Prosecutorial Council, Mr. Valdrin Krasniqi, on the fifth floor (5) building of the State Prosecutor, street "Luan Haradinaj" - Prishtina, office number 504, sealed in an envelope or by mail.
